

# Reintroduction of Cruise Tourism

## Reopening Plan: Phase 5



## What You Need to Know:

### Travellers Arriving by Cruise Ship

- ✔ Any person disembarking must have completed an approved vaccine course at least 14 days prior to embarking the cruise ship (*This also applies to captains and crew members*)
- ✔ Unvaccinated children under the age of 12 years can only disembark when accompanied by a fully vaccinated adult.
- ✔ Any person who tests positive for the virus or shows any symptoms of the virus is not permitted to disembark.

Prior to arrival, a Customs and Border Control officer shall be provided with a list of the vaccination status in relation to each passenger and crew member.

While disembarked, all passengers must comply with local regulations.

## For All Other Means of Travel:

### Who Can Travel

- ✔ All vaccinated travellers
- ✔ Unvaccinated Caymanians, Residents and Work Permit Holders
- ✔ Unvaccinated visitors who have close ties to the country (*Persons who own local properties and businesses, or who are a spouse, civil partner, parent, step-parent, child, grandchild, step-child, or grandparent of a Caymanian or Resident*)
- ✔ Unvaccinated children under the age of 12 years old

### Who Cannot Travel

- ✘ Unvaccinated tourist visitors (*including unvaccinated tourist visitor age 12 and over*) who do not have close ties to the country
- ✘ Unaccompanied unvaccinated tourist visitor children (*i.e. under the age of 12*)

### Applying to Travel

- ✔ All incoming travellers are required to apply on the Travel Cayman Portal and will be issued with a travel certificate which is required for entry
- ✔ Unvaccinated travellers are required to **apply no less than 5 days prior** to departing for the Islands
- ✔ Vaccinated travellers are required to **apply no less than 72 hours prior** to departing for the Islands

### Pre-Arrival COVID-19 Testing

- ✔ All travellers aged 5 years and over must provide a negative result from a PCR or certified antigen-detecting rapid diagnostic test (LFT) taken no earlier than the day before departure

### Quarantine Period (7 days)

- ✔ Unvaccinated travellers (*age 12 years and over*) along with all unvaccinated members of their household

GPS Tracking is required for all travellers and their companions age 10 years and over who are approved to quarantine at a private residence.

Vaccinated household members are not required to quarantine but will be required to undergo daily LFT for 7 days if they wish to leave the premises.

### Children

- ✔ Unvaccinated children under the age of 12 years old will assume the vaccination status of their adult travel companions
- ✔ All children age 12 years and over are required to be vaccinated to be exempt from quarantine

Unaccompanied unvaccinated tourist visitor children are not permitted to enter.

### Inter-island Travel

- ✔ There are no restrictions on Inter-Island travel for fully vaccinated persons nor unvaccinated persons
- ✔ Unvaccinated persons are required to produce a negative PCR or certified LFT taken no earlier than the day prior to departure
- ✔ Unvaccinated travellers under the age of 18 are not required to undergo testing if they are accompanied by an accompanying person who has completed an approved vaccine course at least fourteen days prior to the accompanying person's date of travel
- ✔ Travellers under the age of 5 are not required to undergo testing
